MEET OUR SPEAKERS

► **Diane Adamczyk, O.D.** — is a PCO graduate and currently the Director of Residency Education at SUNY, State College of Optometry. She did her residency at the Newington Veterans Administration Hospital. In addition to being at SUNY since 1986 and she also had worked in a private practice for many years. Dr. Adamczyk lectures internationally and has written articles, chapters and coauthored the textbook, *Primary EyeCare in Systemic Disease*. She is actively involved in the Accreditation Council on Optometric Education, as both a member of the Residency Subcommittee and site team chair for numerous residency accreditation visits. Dr. Adamczyk is also the chair of the American Optometric Association's Clinical Resources Executive Committee, chair of the Evidence Based Optometry Committee, and she chaired the revision of the clinical guideline, *Diabetes Mellitus* and currently chairs the *Adult Eye Exam Guideline* and *Pediatric Eye Exam Guideline*.

► **Andrew Gurwood, O.D.** — Dr. Andrew S. Gurwood is a Professor of Clinical Sciences, an attending optometric physician in Module 1 of The Eye Institute of the Pennsylvania College of Optometry at Salus University and a member of the clinical staff of Albert Einstein Medical Center, Department of Ophthalmology. Dr. Gurwood earned a Diplomate from the American Academy of Optometry in the Section of Primary Care. He currently serves the profession at large through participation on the Editorial Boards of *Review of Optometry*, *Clinical and Experimental Optometry (Aus)*, and *The Spanish Journal: Optometry*. Other accomplishments include being a founding member of The Optometric Retina Society, a member of The Optometric Glaucoma Society, a Charter (Founding) Member of The Optometric Dry Eye Society, an Abstract Writer for Optometry: *The Journal of The American Optometric Association* and Diagnostic Quiz Columnist for *Review of Optometry Journal*. Noteworthy, are the publication of his textbook "*The Optic Nerve in Clinical Practice*," (Butterworth / Heinemann) and his continuing efforts seen in *Review of Optometry's* yearly supplement *The Handbook of Ocular Disease Management*.

► **Marc Myers, O.D.** — is a Senior Staff Optometrist at the Coatesville Veterans Affairs Medical Center in Coatesville, Pennsylvania. He also is guest lecturer and adjunct clinical faculty at the Pennsylvania College of Optometry. Dr. Myers contributes numerous publications and lecture throughout North America on the topic of Ocular Disease.
